1. Introduction

Welcome to the PATH, a membership site operated by The Peaceful Place, LLC (“we”, “us”, “our”). We value your privacy and are committed to protecting your personal information. This Privacy Policy explains how we collect, use, share, and protect your information when you use our membership service, located at <https://www.pathforhealthyliving.com/> (“Service”).

By using our Service, you agree to the collection and use of information in accordance with this policy.

2. Information We Collect

We may collect the following types of information:

Contact & account information. When you sign up for the membership, we collect your name, email address, billing information, username/password, and other registration details.

Payment information. For membership subscriptions (monthly/annual) we collect payment details (via our payment processor) such as credit card info (note: we do *not* store full card data ourselves; the payment processor does).

Usage data. We collect data about how you access and use the Service — e.g., pages viewed, resources downloaded, log-in timestamps, IP address, browser/OS type, device identifiers, and other analytics.

Communication data. If you contact us (via email, contact form, support chat), we will retain that correspondence.

Optional Profile / Personalization data. If you provide additional information (e.g., preferences, goals, feedback, profile details), we may collect and store that as well.

Cookies and tracking technologies. We use cookies, web beacons, and similar technologies to track usage, monitor performance, for analytics, and to personalize your experience.

3. How We Use Your Information

We use the collected information for the following purposes:

To provide and maintain our Service (e.g., verify accounts, process payments, deliver content).

To manage your membership subscription (billing, renewals, cancellations, refunds).

To communicate with you (e.g., service updates, notices, responses to your queries).

To improve and personalize the Service (e.g., understanding your usage, providing recommendations, monitoring and enhancing performance).

To analyze usage and trends so we can improve our offerings.

To enforce our Terms & Conditions and other policies.

To comply with legal or regulatory obligations.

4. Sharing and Disclosure of Information

We may share your information in the following circumstances:

Service providers. We may share your data with third-party service providers who perform functions on our behalf (e.g., payment processors, hosting providers, analytics services).

Legal requirements. We may disclose your information if required by law, court order, or governmental request, or to protect our rights, property, or safety of other users.

Business transfers. If we are involved in a merger, acquisition, sale of assets or other business transaction, your information may be transferred as part of that transaction (subject to confidentiality commitments).

With your consent. We may share your information for other purposes if you explicitly consent.

5. Data Retention

We will retain your personal information for as long as is necessary to fulfill the purposes described in this policy — for example, while your membership is active, and thereafter for a reasonable period to comply with our legal obligations, resolve disputes, enforce our agreements, or for historical/archival purposes.

6. Security

We take reasonable administrative, technical, and physical safeguards to protect your personal information from unauthorized access, use, or disclosure. However, no internet or email transmission is fully secure, and we cannot guarantee absolute security.

7. Your Rights and Choices

Depending on your jurisdiction and applicable laws, you may have certain rights regarding your personal information, including:

The right to access, update, or correct your information.

The right to request deletion of your personal data.

The right to object to or restrict certain processing of your data.

The right to withdraw consent where we rely on it.

The right to portability of your information (where applicable).
