

Refund Policy

1. Overview

At **The Path for Healthy Living** (operated by *The Peaceful Place, LLC*), we strive to provide high-quality, meaningful content, guidance, and experiences to support your journey toward sustainable healthy living.

Because membership benefits include immediate access to digital content, guided practices, and community features upon enrollment, specific refund conditions apply as outlined below.

2. Membership Purchases

a. Monthly Memberships

Monthly memberships are **non-refundable** once the payment has been processed.

You may **cancel your membership at any time**, and you will retain access until the end of your current billing period.

After cancellation, you will **not be charged** for future months.

b. Annual Memberships

Annual memberships may be eligible for a **partial refund** if canceled **within 7 days of purchase** and if you have not accessed or downloaded significant content (as determined by usage logs).

After 7 days, all payments are **non-refundable**, but you will maintain access for the remainder of your billing year.

3. Promotional or Trial Offers

Free trials or discounted introductory memberships are **non-refundable** once converted into a paid subscription, unless canceled before the renewal date.

Once payment has processed following a trial, normal refund rules (as stated above) apply.

4. Digital Product Access

Because our membership includes **immediate access** to exclusive digital materials (such as courses, recordings, or guides), refunds are not available once a member has logged in and accessed these materials, except as required by applicable consumer protection laws.

5. Technical or Billing Issues

If you experience duplicate charges, payment errors, or technical difficulties preventing access to your membership, please contact us within **7 days** of the issue. We will promptly review and, if appropriate, issue a refund or credit to your original payment method.

6. Cancellations

You can cancel your membership anytime by:

Logging into your member dashboard and selecting **Cancel Membership**, or

Cancellations take effect at the **end of the current billing cycle**. You will continue to have access until that date.

7. Refund Exceptions

Refunds may be issued at our sole discretion in special circumstances, such as:

Duplicate transactions

Technical errors preventing access to the Service

Mistaken multiple account sign-ups

In these cases, refunds will typically be processed within **5–10 business days** after approval.
